# 1. Admission Policy

## (1) Tohoku University

### Philosophy & Mission

With over 100 years of history and distinguished traditions, Tohoku University has developed excellence in education and research under its principles of "Research First," "Open Doors," and "Practice-Oriented Research and Education" since its establishment in 1907. The university will maintain these traditions while looking toward even more dramatic progress in the future. As a world-leading center of education and research, it will contribute greatly to the human race by grappling with the difficult and complex issues facing the 21st century. Tohoku University will focus its efforts of its faculties, graduate schools, and research institutes to foster ethical international leaders who will carry humanity into the future, while expanding its globally renowned creative research for the benefit of society at large.

### Characteristics

#### 1) Three Foundational Ideals

"Research First," "Open Doors," and "Practice-Oriented Research and Education" — soon after its founding, Tohoku University established this set of unique ideals, the substance of which it is continually developing in response to our changing times.

#### 2) Rich Educational Environment

Tohoku University has numerous research organizations and facilities, primarily comprising 10 undergraduate schools, 15 graduate schools, 3 professional graduate schools, and 6 research institutes. Research institute staff also participate in educational activities (there are approx. 3,000 instructors; enrollment limits are approx. 2,400 for undergraduates, 2,700 for graduate students).

#### 3) Research University

Tohoku University is a school that continuously produces numerous internationally recognized research results and concertedly pushes forward with leading-edge research and education.

#### 4) Active Regional/Industrial-Academic Ties

The university is actively working to expand its diverse regional and industrial ties.

#### 5) Globalizing Education and Research

Among Japan's national universities, Tohoku University is one of the top schools in terms of agreements with overseas universities. It is actively expanding exchange in education and research. The university strives to foster globally active individuals through strong support for studying abroad by Japanese students, as well as recruitment of numerous international students.

### Ideal Tohoku University Applicants

Tohoku University seeks students who sympathize with the university's principles and who are motivated by:

1. the desire to make outstanding contributions as world-class researchers by addressing the issues facing humanity in the 21st century, and
2. the desire to make outstanding contributions to the development of society as highly specialized professionals who possess abundant knowledge and leadership.

To realize these ambitions, students should also have strength of will, academic curiosity, a broad perspective, and an excellent foundation of specialized knowledge and abilities.

#### Tohoku University Admissions Process (Graduate School)

Depending on the number and type of candidates sought, Tohoku University graduate schools provide multiple categories of, and opportunities for undergoing, entrance exams to meet the needs of candidates from diverse backgrounds. Schools may evaluate the candidate's qualifications, abilities, and specialization using interviews, application documents such as research plans, proficiency exams, and external tests.

#### (2) Tohoku University Graduate School of Environmental Studies

By bringing together the multidisciplinary knowledge of Tohoku University, the Graduate School of Environmental Studies (GSES) aims to establish environmental science as an integrated discipline that transcends the traditional divisions of the humanities and sciences in order to establish a culture supporting sustainable development as well as technologies and systems needed to establish resource-circulating societies. To achieve this goal, GSES has set the educational objective of fostering individuals equipped with a combination of broad knowledge and deep expertise relevant to the understanding and solving of environmental problems. By effectively integrating insights from existing academic fields while creating new frontiers of knowledge, GSES seeks to foster environmental professionals capable of playing an active role in the international community. GSES is looking for students who share these goals. We especially welcome applicants with a strong desire and ability to carry out study and research, and the fundamental academic skills needed to achieve their goals.

Six entrance examination subject-groups are conducted to match the varying expertise of applicants. In each subject-group, students are selected through six different examination procedures: General Selection, Special Selection for Recommended Students, Special Selection for Working Persons, Special Selection for International Students, and Special Selection for Graduates of the Early Graduation System. Selection is made based on the applicant's motivation to conduct research in line with the educational goals of GSES, as well as academic knowledge and outstanding research capabilities.

#### (Master's course (2 years))

In the General Selection examination, applicants are required to take a written examination to evaluate their specialized knowledge in the relevant field, logical thinking, and ability to write an essay about a specific topic. In addition, applicants must sit an oral examination or interview (here in after referred to as the "oral examination") to evaluate their motivations and research ability as well as their capacity to carry out environmental science in an integrated setting. The selection process is based on a comprehensive evaluation that includes the results of both the written and oral examination, with emphasis placed on the written examination's outcome.

Although the content of the examinations for the Special Selection examinations differs according to the characteristics of the targeted applicants, the evaluation and scoring procedure is essentially the same as that of the General Selection examination. However, in the case of the examination for the Special Selection

for Working Persons, the relevance of the applicant's professional experience to the proposed research topic is assessed during the oral examination. In the case of the Special Selection for International Students examination in the Humanities and Social Science Group, whether the applicant's Japanese proficiency is sufficient for research will also be assessed. In all fields, we expect applicants to have acquired the English language skills necessary for writing and discussing research papers as well as understanding the fundamentals of each specialized field before entering the GSES master courses.

Entrance examinations are conducted for each entrance examination group to which each research field belongs. For an overview of the entrance examination groups and which the laboratory belong to which entrance examination groups, please refer to Appendix 1 "Departments, Entrance Examination Groups, and Laboratories".

**Note:** Only applicants from the General selection and Special Selection for Working Persons groups can apply for the General environment group.

## 3. Application Eligibility

- ◎ Applicants for the General Selection (October enrollment) must fall under one of the categories (1) to (10).
- ◎ Applicants for the Special Selection for Working Persons must, in principle, have at least two years of work experience after graduating from university, etc., and must fall under one of the categories (1) to (10).
- ◎ Applicants for the Special Selection for International Students must be those who have received university education in Japan as international students or have received overseas university education and fall under any of the following (1) to (10).

In addition, for the “Human and Social Science Group”, applicants must have passed Level N1 of the Japanese-Language Proficiency Test, organized by the Japan Foundation and the Japan Educational Exchanges and Services, or Level 1 of the old test (up to 2009), or be expected to pass by the day before the entrance examination.

- ◎ Applicants for the Special Selection for Early Graduate Students must have graduated after completing

between 3 and 4 years of study, and must fall under (1) below.

The applicant must:

- (1) Have graduated from university or expect to graduate by September 2026.
- (2) Have received a bachelor's degree under Article 104 Paragraph 7 of the School Education Law of Japan, or expect to receive such a degree by September 2026.
- (3) Have completed a 16-year curriculum of school education overseas, or expect to complete such education by September 2026.
- (4) Have completed a 16-year curriculum of school education in Japan by taking correspondence courses offered by schools outside Japan, or expect to complete such education by September 2026.
- (5) Have completed a university education by taking courses designated by the Minister of Education, Culture, Sports, Science and Technology in an educational institution in Japan recognized as adopting the educational system of a foreign country and having the curriculum of that country (only when the person completing that education is regarded as having completed 16 years of that country's education), or expect to complete such education by September 2026.
- (6) Have been conferred a degree equivalent to a bachelor's degree upon completion of a curriculum that has a course term of three years or longer at a university or other school (limited to schools whose overall educational and research activities have been evaluated by the relevant country's government or a government-approved individual, or are designated separately as having met this requirement by the Minister of Education) in a foreign country (including cases in which the student completed the curriculum by taking subjects conducted by said school via distance learning while the student resided in Japan, and cases in which the student has completed a curriculum at an educational facility that is positioned within that country's educational system as per the previous item) or expect to receive such a degree by September 2026.
- (7) Have completed a specialized course of a special training school designated by the Minister of Education, Culture, Sports, Science and Technology (only when the schooling is at least four years in length and other criteria stipulated by the Minister are met), on or after the date stipulated by the Minister, or expect to complete such course by September 2026.
- (8) Have been designated as eligible by the Minister of Education, Culture, Sports, Science and Technology under ministerial ordinance No. 5 of 1953.
- (9) Have been admitted to the graduate school of another university in accord with Article 102 Paragraph 2 of the School Education Law and is recognized by this Graduate School as having suitable academic ability for study in this program.
- (10) Be aged 22 or above and, through individual admission qualification screening, be recognized by this Graduate School as having achieved at least the equivalent academic abilities of a university graduate.

Note 1: Those who plan to apply for the Special Selection for Working Persons and are expected to graduate from university by September 2026 should contact the Academic Affairs Section of the Graduate School of Environmental Studies by May 26, 2026.

Note 2: Applicants should consult with the faculty member of the laboratory you wish to enter before the application period regarding your research plan after entering the graduate school.

Note 3: Applicants who plan to apply under application eligibility (6) must contact the Academic Affairs Section of the Graduate School of Environmental Studies by May 26, 2026 for prior confirmation.

Note 4: Applicants who plan to apply under application eligibility (9) or (10) must submit the documents specified by the Graduate School by May 26, 2026 after contacting the Academic Affairs Section of the Graduate School of Environmental Studies in advance for application eligibility screening.

Note 5: Applicants who plan to apply for the Special Selection for Early Graduate Students and who are from other universities should contact the Academic Affairs Section of the Graduate School of Environmental Studies by May 26, 2026.

Note 6: This graduate school does not apply the application eligibility for “those who have been enrolled in a university for three years or more (including those specified by the Minister of Education, Culture, Sports, Science and Technology as equivalent to this) and who are recognized as having acquired the credits specified by this graduate school with excellent grades”.

Note 7: Applicants who are currently employed as a faculty member or staff member at Tohoku University and will continue to work at the university after enrollment should contact the Academic Affairs Section, Graduate School of Environmental Studies by May 26, 2026.

Note 8: For foreign students living overseas, it may take 2 to 3 months from the time of the announcement of results until you can enter Japan after receiving a student visa, and in some cases it may be difficult to complete the second semester's coursework. Therefore, please consult with your prospective academic advisor about the timing of the entrance examination you will take, etc., before applying. Please note that we cannot respond to requests for early issuance of a certificate of eligibility for residence status after you have been accepted. Please do not take any steps to come to Japan that are contrary to the instructions of our university.

#### **4. Application Procedures and Application Period**

The application procedure is carried out by entering the designated online application system, The Admission Office (hereafter referred to as the “TAO”), and submitting the original application documents. Applicants should follow the procedure below and complete the application procedure within the application period.

## 1) General flow

### 1 Confirming Application Guidelines and Obtaining the Necessary Documents



- Please carefully check the information in this Application Guidelines, including the application eligibility and the necessary application documents.
- For application documents, such as certificates of (expected) graduation, transcripts, and other support documentation, please request them in advance from the university you attended.

### 2 Paying the Examination Fee



- Follow the directions on the Application Guidelines. Use an ATM (at a financial institution or convenience store) or online banking to pay via transfer to the designated bank account. A prescribed fee will be charged when making the payment (to be borne by the applicant).
- After making the transfer, attach documents that show the payee's account information, the amount, the date of transfer, and the name of the payer—such as a copy of the ATM statement or a copy of the screen of the completed Internet banking transfer—to the Payment Confirmation for Examination Fee, and upload the scanned data to the TAO Application Registration website

### 3 Registering an Application via application registration website

- Please send the original documents listed in the application documents by express simplified registration mail or a method that allows you to track the delivery status, in accordance with the instructions in (3) and (4) of "3) Application Method".
- Please note that if the documents do not arrive by the date specified in the application guidelines, your application will not be accepted. (In some cases, it may not be necessary to submit the original documents, depending on the selection category or entrance examination group for which you are applying.)

- (4) As a general rule, please submit the original paper documents by post.

Submissions must arrive by the final day of the acceptance period stated below.

Please use a commercially available envelope and write in red on the front of the envelope “Original documents for the entrance examination for the Master’s program of GSES (Oct. enrollment)”, and be sure to send it by Express simplified registration mail. (If you are sending from outside Japan, please send the documents in a method that allows you to check the delivery status.)

If you are submitting in person, please bring it by 16:30 on the last day of the acceptance period.

## 7. Enrollment Procedures, etc.

- (1) The enrollment procedures are scheduled to take place in September 15, 2026.

The detailed information will be provided via email or message from the TAO after the announcement of results.

- (2) Fees necessary at the time of enrollment Students entering from another school

(a) Admission fee: 282,000 yen (tentative)

(b) Tuition (second semester): 267,900 yen (annual 535,800 yen) (tentative)

**Note 1:** The above amounts are tentative. In the case that admission or tuition fees are Revised, the new fees will become applicable from the time of the revision.

**Note 2:** Information regarding payment, waiver, deferment of admission fee and tuition fee payment will be provided in the enrollment registration documents sent after the announcement of successful applicants.

**Note 3:** In addition, as other miscellaneous expenses, international students must pay the insurance premium for the “Comprehensive Insurance for Students Lives Coupled with 'Gakkensai' for International Students” (20,130 yen (B Type)).

Details will be provided in the enrollment registration documents sent after the results are announced. (The amount is as of April 1, 2026. The premium amount is for two years.)

Please note that the existing tuition exemption program based on financial need will be discontinued at the end of the 2026 academic year. A new scholarship program for international students will be established beginning in the 2027 academic year.

(Scholarships equivalent to either the full amount of tuition or one-half of the tuition shall be awarded to approximately the top one-third of students selected based on entrance examination results, academic performance, and other relevant factors.)

(3) The entrance ceremony is scheduled to be held on October 1, 2026, and classes are scheduled to begin on October 2.

## 8. Eligibility for Long Term Study Program

Some applicants, due to the need to continue with employment or other special circumstances (**Note 1**), may request permission to follow a planned course of study longer than the normal period of two years in order to receive their degree (**Note 2**).

This Graduate School offers such an option, called a “Long Term Study Program,” to those who qualify in an advance screening exam. Long term master’s students pay the same amount over the length of their studies as those enrolled in the standard two-year program.

If you wish to apply for the Long-term Study Student Program, please be sure to enter your preference in the designated section of the application form, as we will inform you of the application procedure separately.

Please note that the system is applicable from the time of entering the university, and as a general rule, it is not possible to change to the Long-term Study Student System during your time at the university.

**Note 1:** To be eligible for this program, the applicant must (1) be employed full-time by a company or be self-employed, (2) be perform child birth, child care and nursing care, etc., (3) be otherwise determined by this Graduate School to be suitable for the program.

**Note 2:** The period of study may not be extended beyond four years, but it is possible to request that the allowed period be shortened. In principle, no special curriculum will be prepared for students in the long term study program.

**Note 3:** The deadline for applying to the Long-term Study Student Program is the date of enrollment

registration. Details will be provided in the enrollment registration documents.

## 9. Handling of Personal Information

- (1) All personal information gathered by Tohoku University shall be treated with due care in compliance with the relevant university regulations, such as the Act on the Protection of Personal Information (2003, Act No. 57), and the National University Corporation Tohoku University Policy on the Protection of Personal Information, and security measures will be taken to protect it.
- (2) Personal information, such as examination scores, used to screen applicants will be used exclusively for educational purposes, such as selecting applicants, enrollment procedures, pre-enrollment instruction, follow-up surveys, post-enrollment student support (scholarships, tuition waivers and health management etc.) and academic advising, or in connection with tuition collection etc., or surveys/research (surveys/analysis related to entrance examination improvements and reasons for applying; including analysis using the enrollees' personal information after enrollment).
